# RESEARCH INSTITUTE

FDDI has been nurturing multi-disciplinary research institutes and has established the following 29 research institutes/centers.

## Affiliated Centers /Institutes

### • Center for BRICS Studies

The Centre for BRICS Studies was established in March, 2012. It provides China with strategic consultation on promoting cooperation among BRICS countries in global governance. It is an academic institute devoted to multi-disciplinary researches on the cooperation among BRICS countries on major international issues and BRICS participation in global governance. The Centre for BRICS Studies is the first and the most active and devoted platform in China in promoting BRICS pragmatic cooperations.

### • BRICS Universities League ( BRICS UL )

BRICS UL shall act as a platform for bilateral and multilateral exchanges between universities in BRICS countries, as an important mechanism for promoting education cooperation and cultural exchanges between BRICS countries, and also as an international think tank supporting policy research in BRICS countries. From January 2019, Fudan University shall serve as the BRICS UL Secretariat to further promote the work of the BRICS UL. The specific work is undertaken by the Center for BRICS Studies, FDDI.

### • BRICS Information Sharing and Exchange Platform

In response to the relevant initiatives of the 2013 BRICS Summit in Durban, the platform aims at boosting the trade and investment ties among BRICS countries with a view of being an international, non-profit and authoritative information portal. The official website is: [www.brics-info.org](http://www.brics-info.org). The platform has become a comprehensive BRICS information dissemination platform approved by the 2015 BRICS Summits in Brazil. Now the website gets as high as 200,000 hits per month. It is currently the largest and also the most authoritative database for researches on BRICS cooperations in China.

### • BRICS Summer School

This programme is held from July to August every year since 2014. It gathers both undergraduate, graduate students and young scholar from BRICS countries for a one-month study in Shanghai. There are two main modules: "Global Governance and Cooperation among BRICS" and "China's Politics and Diplomacy" delivered by domestic and foreign prestigious scholars in BRICS studies, and also combined with other events in BRICS theme. This programme is the first programme in BRICS education cooperation with the largest substantial progress. It is an outstanding platform for youth communications in order to enhance BRICS cooperation through people-to-people exchange.



### • Global South Field Research Laboratory

Global South Field Research Laboratory, Fudan University (GSFRL-FDU) was officially established in May 2026. Founded under the guidance of Shanghai municipal authorities and supported by Fudan Development Institute, the lab aims to implement the directives outlined in President Xi Jinping's congratulatory letter on Fudan University's 120th anniversary, which calls for "innovations in knowledge, theory, and methodology in the humanities and social sciences." The lab contributes to national strategic priorities and Shanghai's development as a "Five-Center" city, undertaking initiatives in talent cultivation, academic research, and collaborative exchanges in regional and Global South studies. The lab emphasizes long-term field research in target countries and the development of primary databases to support research. Its methodology combines participant observation, in-depth interviews, oral histories, archival collection, original database construction, and interdisciplinary study, following a framework of problem-driven inquiry, local evidence collection, comparative validation, and cross-disciplinary integration. The lab is committed to building a knowledge production and data accumulation system focused on the Global South, grounded in real-world contexts. Drawing on sustained field research, the lab seeks to develop an independent, explanatory, and internationally communicable theoretical and discursive framework for regional and country studies.

## Global Governance

## Technology & Innovation



### • Center for Global AI Innovative Governance

The Center for Global AI Innovative Governance was inaugurated at the opening ceremony of the 2025 World Artificial Intelligence Conference. Building on Fudan University's strengths in global AI governance, interdisciplinary research, and extensive partnerships, the Center advances its mission through international forums, thematic workshops, and collaborative research initiatives. The Center is committed to fostering talent development, youth exchanges, educational and training programs, AI4S initiatives, and the translation of academic research into practical applications. Its overarching objective is to establish a collaborative platform that connects Shanghai, China, and the global community in AI governance and industry–academia–research cooperation. Through this platform, the Center seeks to promote rule-making, strengthen governance capacity, and contribute to the creation of a globally recognized framework, normative standards and related action guidelines based on broad consensus.

### • Research Center for Technological Innovation Strategy

Research Center for Technological Innovation Strategy was established in August 2024. It is an interdisciplinary research institution aimed at leveraging Fudan University's comprehensive strengths in the fields of humanities, science, life sciences, medicine, and engineering. The center focuses on combining the demands of industrial innovation to conduct research on technological innovation strategies and innovation theories, bridging the innovation gap, and cultivating experts in technological innovation research.



## State & Social Governance

### • Center for Communication and State Governance Research

The Center for Communication and State Governance Research (CCSGR) was established in 2012, and it is the first and only research institution in China that focuses on "communication and state governance". CCSGR integrates seven major disciplines, including Journalism and Communication, Economics, Politics, Computer Science, Sociology, Law, and Philosophy. With the mission of building a first-class university think tank, CCSGR conducts a series of studies on major issues related to communication and state governance. It provides comprehensive, strategic, and forward-looking advisory services for the state on global governance, major institutional reforms, and policy implementation. The Center positions itself at the intersection of modern communication systems and public opinion studies, and it conducts interdisciplinary and innovative research in areas such as youth ideology and values, computational social mentality, and internet platform and AI governance. Annually, the Center releases the *Internet and National Governance Development Report (Blue Book)* and hosts the Communication and National Governance Think Tank Forum.

### • Research Institute of Intergrated Development of Yangtze River Delta Region

Institute of Integrated Development of Yangtze River Delta Region is founded by Fudan University as an endeavor to respond to the strength and needs of integrated development plan of Yangtze River Delta Region. Located in Shanghai, one of the leading cities in the Yangtze River Delta Region, Fudan University acts from a strong sense of duty, mobilizing its academic resources and human capital, exploring social and economic development demands of Shanghai and Yangtze Delta Region at large, and therefore, contributing to the implementation of the Regional Plan for Yangtze Delta Region that has been approved by China's State Council.



### • Reseach Center for State Building

The Reseach Center for State Building of Fudan Universityr was established in July 2011. The State Building Research Center is conducting a research on the subject of national governance. Through interdisciplinary research, the research center summarizes China's development practice and major theories, respond to major strategic issues facing by China's economic and social development, and strives to form brand-based academic achievements, products and activities to serve the country.

### • Shanghai-Hong Kong Development Institute

The Shanghai-Hong Kong Development Institute was jointly founded by Chinese University of Hong Kong and Fudan University in 2001, based on their interdisciplinary strength in the economic, social, political and cultural studies. It is the first institution for cooperative researches and exchanges between major universities in mainland China and Hong Kong after 1997. The Institute provides government agencies and companies with political consultation and recommendations, enhances the influence of universities on the decision-making of the government and offers Hong Kong and Shanghai intellectual supports for their sustainable prosperity and social harmony.

## State & Social Governance

### • Public Performance and Information Research Center

Established in 2008. In recent years, it mainly utilizes intelligent information processing technologies such as big data analysis, cloud computing, mobile internet, and artificial intelligence to conduct research and practice in the field of government performance and social governance. Explore the approach of "Internet +social governance", effectively utilize big data to predict social demands, predict social issues, enhance social consensus, and improve the intelligence level of social governance, achieving a transition from experience-based governance to data-driven governance, and from passive response-oriented governance to proactive predictive governance.

### • Fudan Institute of Social Research

The Fudan Institute of Social Research, founded in 2011, is committed to collecting, sorting and developing the social and economic development data of China. It is attempting to provide scholars with the most competitive research conditions and data services as well as afford the scholars more solid trainings in the investigation methods and applications of social sciences. The Institution encourages inter-disciplinary researches. It is devoted to recording the fruits of civilization and handing down the cultural legacy, which is the duty of an university. It has become a significant and fundamental basis for the "National Think Tank".

## Sustainable Development

### • Sustainable Development Institute

The Sustainable Development Institute is being developed as a university-level strategic platform of Fudan University in response to national strategic priorities and the global sustainable development agenda. Professor Marie Harder is leading its preparatory development. Guided by a problem-oriented, human-centred and transdisciplinary approach, SDI aims to support Fudan's organized research capacity in sustainable development by serving as a hub for strategic coordination, resource integration, institutional innovation and international partnership. During its preparatory phase, SDI will use foundational research on human cognition, values and behaviour as a methodological engine, while forming initial research clusters in climate governance and China's dual-carbon strategy, low-carbon energy transition, megacity governance, ecological restoration, ESG reform for the Global South, and ethical governance of emerging technologies and artificial intelligence. These initial areas are not fixed boundaries, but starting points through which SDI will continue to convene and connect more schools, platforms and researchers across Fudan. Through its integrated RE-CoP framework of Research, Education, Contribution and Partnership, SDI aims to help build China's knowledge system for sustainable development and contribute Fudan insights and Chinese solutions to the post-2030 global agenda.



## Sustainable Development

- **Shanghai Research Institute for Energy and Carbon Neutrality Strategy**

The Shanghai Research Institute for Energy and Carbon Neutrality Strategy is a collaboration effort launched on November 6, 2021 by Fudan University and Shanghai Development and Reform Commission. Geared towards serving strategic objectives of the nation, the Yangtze River Delta and Shanghai in energy transition and carbon peak and neutrality, the Institute will advance the research on the most important but difficult areas of reform and transformation, as well as the forefront challenges in achieving low-carbon development. Specifically, it will focus on the selection of transformation path to achieve carbon peak and neutrality targets, the optimization of policy-based mechanisms, the prevention and control of transformation risks, the construction of market system, the coordination and collaboration among regions and industries, etc. Through carrying out high-level policy and theoretical research to help national and regional governments more effectively resolve the contradictions between transformation and reform, as well as better serve the national goal of creating a green, low-carbon and circular economy, the Institute aims to build itself into a domestic first-class high-end think tank with international influence.

- **Research Center for Theory and Policy of Yangtze River Conservation**

Established in 2022, Center for Yangtze River Conservation Theoretical and Policy Research is a think tank research platform for strategic cooperation between Fudan University and Yangtze River Fishery Supervision and Management Office of MARA. It aims to carry out interdisciplinary research on the Yangtze River conservation and the 10-year fishing ban in the Yangtze River, focusing on the Yangtze River conservation strategy and the overall requirements of aquatic ecosystem protection, and promote the Yangtze River protection and build a new comprehensive management system. Supported by Fudan Development Institute, the center combines theory and practice to exert the influence of relevant achievements and policies research, improve the conversion rate of scientific and technological achievements and intellectual support for management decision-making simultaneously.



- **Shanghai Key Laboratory of Policy Simulation and Assessment for Ecology and Environment Governance**

Shanghai Key Laboratory of Policy Simulation and Assessment for Ecology and Environment Governance (The Key Laboratory) was established in August 2021.

The three major research directions of the key Laboratory include: firstly, the 'Implementation' of major national environmental governance policies and the research on Shanghai's ecological civilization, environmental governance theory and policy innovation. Secondly, Shanghai's environmental governance performance evaluation and policy decision-making mechanism optimization research. In addition to specific ecological environmental issues-oriented collaborative management and governance policy research.

At the same time, Fudan University has a strong foundation in various academic fields, conducts a series of studies on major issues related to environmental management and environmental economics, environmental policy, Multi-system modeling, ecological environment planning and design, low-carbon development theories and practices, etc. The research provides important theoretical and practical support for the high-quality development and high-level protection of Shanghai and even the Yangtze River Delta.

## Economy & Industry

### • **Big Data Laboratory of Consumer Market**

The Big Data Laboratory of Consumer Market is awarded the big data lab by the Ministry of Commerce, Shanghai Municipal Commission of Commerce, and Shanghai Municipal Bureau of Statistics. By collecting big data in the consumer market and promoting its application together with the government, companies, and research institutes, it aims to provide better digital commercial services for the government, market players, and consumers.

### • **Financial Research Center**

The Financial Research Center, founded in 2012, makes full use of the resources of the finance subject and taps the academic influence of the Fudan financial community. Through "Fudan-ZEW Indicator of Chinese Economic Sentiment", "China Financiers Club", "Post-doctoral Research Station" and other key flagship products, the Center aims to create a high-end finance think tank. It has produced a series of quality and influential academic papers that reflects the strength of Fudan. The Center also provides professional comments and effective policy recommendations for major financial decisions of the country and for the building of Shanghai into an international financial center.

### • **Fudan-ZEW Indicator of Chinese Economic Sentiment**

The "Fudan-ZEW Indicator of Chinese Economic Sentiment" is a flagship product of the Financial Research Center. It is jointly developed by the Center and Centre for European Economic Research (Zentrum für Europäische Wirtschaftsforschung, ZEW). Based on the data in "China Economy Proposal" of the Financial Research Center, researchers assess the economic performance and formulate the economic indicator for the coming three months or one year. The indicator is expected to predict as precisely as possible the mid and long-term trends of the economic and financial situation in China. The indicator serves as a reliable reference to and basis for the monetary policy adjustment, industrial policy formulation, the financial market's expectation of the macro-economic trend as well as the response of the real economy to the economic policies.

### • **China Insurance and Social Security Research Center**

The China Insurance and Social Security Research Center is an interdisciplinary research platform founded by Fudan University in 2013 as it integrated the insurance subject resources. The Center intends to study the insurance and social safety issues against the background of national economic transformation and internationalization. It is expected to promote the studies in insurance, social safety, social security, disaster economics, and disaster risk management. Considering the high frequency and violence of disasters in China, the Center provides essential academic supports and policy recommendations for national economic development through strengthened researches and exchanges.

### • **Yangtze River Economic Belt Development Institute**

Yangtze River Economic Belt Development Institute was jointly founded by Cooperation and Communication Office of Shanghai Municipal People's Government and Fudan University. The Institute intends to implement significant national development strategies including "the Belt and the Road", construction of Yangtze River Economic Belt, and so on. With the synergy and innovation model, integrating governments, enterprises, universities, research institutes and users, the Institute is committed to building a high-end think tank and platform to meet the needs of national development, promote the construction of Yangtze River Economic Belt and accelerate the collaboration and development of the basin-wide industry and enterprises.

### • **Center for Strategic Research on Emerging Industries and Financial Risk**

To serve China's strategic needs in emerging industry and financial risk, and to address the challenges of industrial chain vulnerabilities, supply chain disruptions, and financial risks in the international competitive landscape, the Center for Strategic Research on Emerging Industries and Financial Risk was established. Distinguished by its interdisciplinary frontier research, the Center focuses on the coupling risks between real industries (particularly emerging industries) and the financial system. It is committed to conducting systematic and forward-looking research on core topics including risk assessment of emerging industry layout efficiency, supply chain finance risk evaluation, and emerging industry overseas expansion risk assessment. The Center aims to build cutting-edge theoretical frameworks and risk assessment models, cultivate high-caliber interdisciplinary talents, and establish a high-level international cooperation and exchange platform.

## Cultural Heritage

### • International Center for Studies of Chinese Civilization

The International Center for Studies of Chinese Civilization at Fudan University (abbr. ICSCC) is an international platform for research on Chinese civilization. Supported by Fudan's strength in the humanities, ICSCC strives to promote Chinese studies as well as cross-cultural exchange and dialogue amongst the global academic community.

#### • ICSCC Visiting Scholars Program

Started in April 2012, the program is designed for qualified early- and mid-career scholars from outside China whose research focuses on Chinese civilization. To promote the integration of scholarly perspectives and research methodologies from China and abroad, the Center offers visiting opportunities each year to outstanding international scholars in Chinese studies. Since its launch, the program has continuously accepted applications and has selected nearly one hundred scholars through academic review to undertake visiting research. During their residencies, visiting scholars work closely with Chinese counterparts and co-organize academic workshops.

To further disseminate these research outcomes, the "Fudan Chinese Civilization Research Special Issue", which features selected high-quality achievements from visiting scholars' workshops and has developed into an academic publication series with sustained scholarly impact.

#### • Shanghai Hamburg Forum

Co-sponsored by Fudan University and the University of Hamburg, and co-organized by ICSCC and the Chinese Department of the University of Hamburg, the Shanghai Hamburg Forum functions as a regular platform for Sino-German cultural and intellectual exchanges across political, academic, and business communities. As of April, 2013, this biennial forum has been held in turn in Shanghai and Hamburg.

#### • Fudan-ENS Program

Since 2014, ICSCC and the Paris Normal School (École normale supérieure, ENS) have developed a multi-dimensional cooperation in the humanities, with a particular focus on academic exchange and talent cultivation. Academic exchanges are carried out through reciprocal scholar visits, joint academic publications, and regular bilateral seminars.

Talent cultivation is primarily implemented through the Fudan-ENS Master's Program in the Humanities, which has enrolled multiple cohorts of students and successfully prepared and selected a number of outstanding master's graduates to pursue doctoral studies in France. The program has produced positive outcomes in both talent development and academic exchange, providing a stable platform for Sino-French humanities research and for the growth of early-career scholars.

### • Key Laboratory of Intelligent Computing of Digital Culture Protection and Tourism Data

Key Laboratory of Intelligent Computing of Digital Culture Protection and Tourism Data fully leverage the strengths of comprehensiveness and interdisciplinary of Fudan University by combing the superior resources of the School of Computer Science, the Department of Tourism, and Fudan Development Institute, and focusing on the cutting-edge scientific and technological research of intelligent computing of cultural tourism information such as digital cultural rights protection and precise analysis of tourism data. Based on artificial intelligence computing to cognize, protect, evaluate and promote the intrinsic value of cultural tourism information, the laboratory achieves the empowerment of the construction of intelligent cultural tourism, cultivates the inter-disciplinary talents of arts and science in national demand, develops digital and intelligent applications for cultural tourism industry, and provides decision-making consultation for national and local cultural tourism industry development.



## Cultural Heritage

- **Center for Data and Research on Contemporary Social Life**

The Center for Data and Research on Contemporary Social Life (CDRCSL), founded in 2011, attempts to collect and sort the social life materials since the establishment of People's Republic of China in 1949, in order to preserve and study the historical memory of contemporary China. After ten years' efforts, the CDRCSL has collected more than 300 batches of materials about social life from different provinces. And this vast and varied collection now ranks top among similar institutions. Under the support of École des hautes études en sciences sociales France, the Center has successfully edited an electronic publication: China's fieldwork-Zhang Letian's Database of Lianmin Village (<http://www.zltfieldwork.com>). The Center cooperated with the Fudan University Library to build the "Contemporary Chinese Social Life Database" (<https://chinalife.fudan.edu.cn/>), which is also a part of the database of the Humanities and Social Sciences Data Institute of Fudan University. The Center and Fudan University Library jointly launched the "Contemporary China Social Life Materials Co-construction and Sharing Alliance", attracting more than 20 leading university libraries and research institutions both at home and abroad to join this alliance, constructing and sharing the academic resources.

## Coordination and Support Centers/Institutes



- **Comprehensive Laboratory of National Development and Intelligent Governance**

Comprehensive Laboratory of National Development and Intelligent Governance leverages the strengths of the disciplines of Philosophy and Social Sciences of Fudan University by fully utilizing advanced methods such as artificial intelligence, big data, machine learning. The lab dedicates to building software and hardware systems with intelligent simulation features and potentials, as well as other simulation predictions and evaluations. Based on the intelligent approach, the lab aims to deeply analyze the profound interactions between various actions which promote national development and governance subjects to contribute to the overall modernization of national governance.

- **International Research Institute of Global Cyberspace Governance**

International Research Institute of Global Cyberspace Governance is one of ten institutes selected by Cyberspace Administration of China and Ministry of Education of the People's Republic of China in July 2018. Incubated at FDDI, the institute has been implemented and now officially opened, with Shen Yi, professor of FDDI and SIRPA at Fudan University, serving as the Director. The Institute will focus on the key research directions, facilitate collective action among governments, enterprises, universities, and research institutes, develop deepened and broadened international cooperation, strive to achieve major breakthroughs in strategic researches and technology governance of c, in order to build an advanced and credible international think tank and contribute to the academic development and disciplines integration process in Fudan University.

## • Fudan Institute on Ageing



Fudan Institute on Ageing (FIA) was founded in August 2021. It is the first academic entity on ageing research among China's higher education institutions. FIA integrates academic resources from the university's departments and faculties in social sciences and collaborates with Fudan scholars from the arts and humanities, science and engineering, medical studies, and public health. FIA focuses on five areas of research: governance on ageing society, development of Silver Economy, ethical and cultural issues in ageing, health and wellness of older

FIA aims at establishing itself as a leading academic platform and interdisciplinary research team by formulating a "China's approach" to governance on ageing society and disseminating "China's wisdom" on tackling population ageing.

## • People-Centered City Institute

People-Centered City Institute was founded in January 2025, affiliated with Fudan University under the overall guidance of the Publicity Department of the Shanghai Municipal Party Committee.

## • Innovation Center for Digital Intelligence Health and Governance

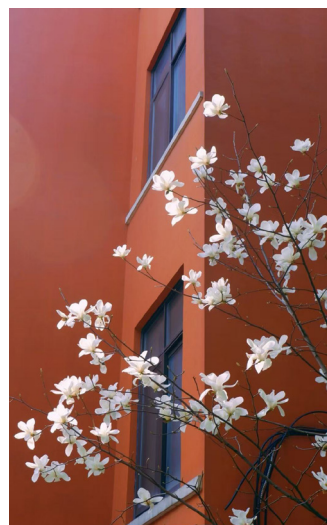

The General Secretariat of LAS-Fudan Centre for Global Leadership Development was jointly established by Fudan University and the General Secretariat of the League of Arab States as a key platform for their strategic collaboration. The Centre focuses on China-Arab future global leadership research and responds to the "Eastward Shift" of international organizations. 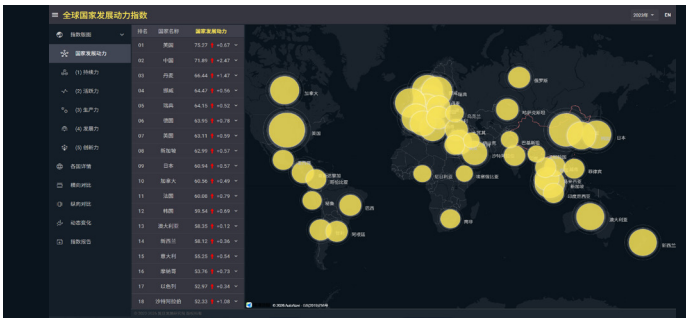

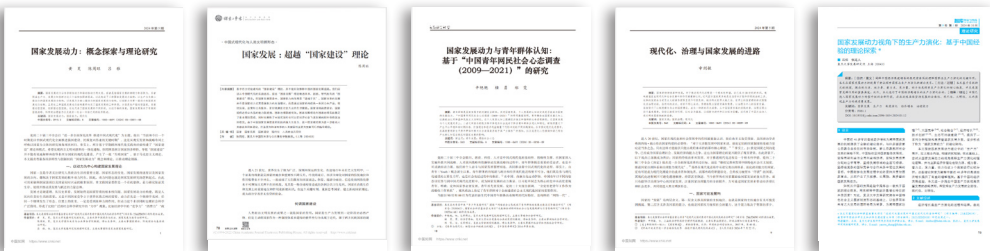

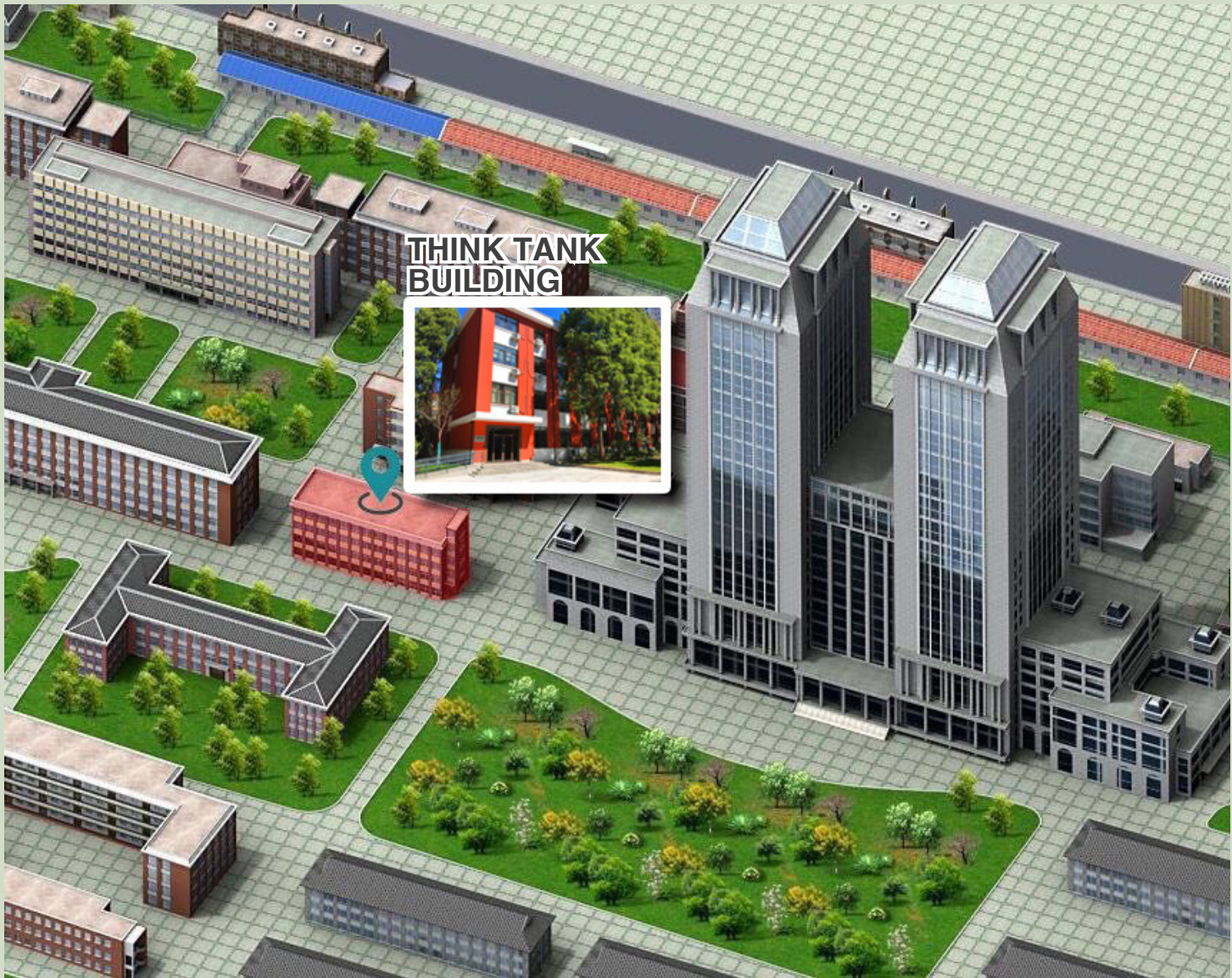
### Length of papers
